Behavioral Expectations of Adults

• When participating in or acting on behalf of the Parks & Rec. Dept. programs, adults are expected to conduct themselves in accordance with accepted standards of social behavior, to respect the rights of others and to refrain from any conduct which may be injurious or detrimental to the Parks & Recreation program.

The following actions constitute misconduct for which adults may be subject to disciplinary action.

- Falsifying information, dishonesty or cheating, in relation with any Parks & Recreation program or activity.
- Obstructing or disruption of any Parks & Recreation activity or the aiding and/or encouraging others to engage in such conduct.
- Failure to comply with specific rules of any program, contest or activity implemented by the Brown Co. Parks & Rec. Department.
- Failure to comply with the direction of Parks & Recreation officials acting in the proper performance of their duties.

Conduct:

- The judgment of Officials is final and can NOT be appealed
- No derogatory remarks to or about officials or volunteers
- No unsportsmanlike conduct, i.e. jeering, profanity or profane gestures
- Poor sportsmanship will not be tolerated! (see penalty and appeal)

Poor Sportsmanship / Technical Foul Penalty:

- Unsportsmanlike vs non-unsportsmanlike technicals. The referee and/or supervisor will make the determination which type of technical will be given.
- Non-unsportsmanlike technical examples of this type of technical foul include (hanging on the rim, not having uniform, calling a timeout when you don't have any, delay of game, minor verbal outburst such as "make the call"). This will result in two shots and the ball for the opposing team but will not result in a player ejection. However, two non-unsportsmanlike techs in the same game will result in an ejection for the remainder of that current game.
- Unsportsmanlike technical examples of this type of technical include (cursing, threatening another player or official, excessive hard fouls, pushing another player in anger etc). This will result in the player sitting out the remainder of game and the opposing team will get two shots and possession of the ball.
- Note: This could lead to a suspension based on the severity of the offense (see verbal intimidation below).

- 2nd unsportsmanlike technical offense player must sit out the reminder of the current game, plus next game.
- 3rd unsportsmanlike technical offense suspension for remainder of current league season and tournament (no refund will be given.)
- Any intentional verbal intimidation or physical altercation toward another participant or Official will result in immediate suspension for a length of time determined by the Board. The Director may suspend any individual for rule violations or misconduct until the Board meets to consider an action.

Appeal Review Process and Fee:

- <u>Any</u> suspensions may be appealed to the Parks and Recreation Department
- The official scorekeeper must be informed with date and time recorded in the score book at the time of the appeal.
- All appeals must be filed in writing at the Parks & Recreation office no later than one working day following the game in question.
- A \$50 appeal fee must accompany all appeals. If the appeal is upheld the fee will be returned. If appeal is denied the fee is retained.

Men's Adult Basketball – League Rules:

Player Eligibility:

- 16 years of age and NOT a participant of a High School Basketball team
- May participate on ONE Parks & Recreation team only
- Player fee paid prior to participation, by deadline
- Complete and sign a registration and waiver of liability form
- Players can be added until 3rd game prior to tourney *see fees

Player Fees:

- Player fees must be paid prior to participation.
- \$10.00 late fee will be charged after registration deadline (NO EXCEPTIONS)
- Added players must complete registration form, pay fee (including late fee) and submit to Parks & Recreation office prior to their first game.

<u> Team / Tourney:</u>

- Team Uniform (shirt) Penalty Team technical for every player in game out of uniform = 1 shot per player and ball out of bounds.
- \$15.00 Forfeit Penalty Team failure to show or field a team with a minimum of four (4) players.
- Forfeiture penalty of \$15.00 must be submitted to Parks & Recreation Dept. office prior to next scheduled game to remain eligible for season play.
- Minimum of three (3) scheduled season games must be played to be eligible for post season tournament play. (*possible exception due to health or injury*)

Facilities:

• High School guidelines must be followed for continued use of facilities.

- After games monitor your area. Don't leave trash or personal items.
- No player or fans are allowed in the Main Gym of the High School for any reason. This includes children and family/friends of the players. Players will be held responsible and could face disciplinary action.

Playing Rules – IHSAA Except as follows:

- 1. 2 20 minute halves / running clock except for;
 - a. Time outs b. Final minute of first half c. Final 2 minutes of game [Clock will NOT stop if a 20 point or more lead exists]
- 2. Half Time Break 5 minutes only
- 3. Teams may start games with four (4) players
- 4. Game time is forfeit time
- 5. Overtime One 2 minute overtime, then sudden death
- 6. Two timeouts per half (timeouts do not carry over)
- 7. Timeouts can only be called by a player on the court
- 8. All other rules follow IHSAA rules
